Strengthening the Bond

From the 2013 Theta State Convention Chairperson to the 2013-2015 Theta State President in just a few months overwhelms me with feelings of challenges, expectations and responsibilities. The most important reason I am able to curb anxieties and face this new job is YOU. DKG sisterhood has become one of the most important parts of my life. In the last decade, many of you have become more than just role models for me, but women I am privileged to call my mentors, advisors and friends.

As I stated in April upon accepting the nomination for Theta State President, I have two important goals in mind and heart as we— as Theta State sisters— strive **To Unite** women educators of the world in a genuine spiritual fellowship. First, I hope to have frequent contact with chapters. Second, I want to have an open line of communication with all members. These goals are not just for me personally, but for all of us as a state organization. After accepting the nomination for State President and seeking members to serve in other leadership positions, I was heartbroken at the number of sisters who had suffered hardships that I didn't know about in the past year! My DKG sisters are more important to me than that, and I do want to be there for them.

My training at the Northwest Regional Conference in Cheyenne, Wyoming, included a session which focused on these goals. The session entitled, "Things A Leader Must Have!" encouraged state presidents to exhibit trust, communication and relationships in order to be successful as state leaders. To get trust, you must give trust. Maya Angelou said, "People will forget what you said, what you did, but will never forget the way you made them feel!" Utilizing multiple types of communication, including nonverbal, is vital to leader success. We are all leaders within our chapters and are part of this organization as key women educators. Building relationships will create a mutual vision that will help an organization like Theta State to grow.

We also learned a lot about membership data. Did you know that a summary of the Dropped Member Survey results indicated that 43.9% of past members surveyed said that they would be likely to reinstate their membership in the future? Wow! How many of them have we asked? Here are some incentives that State Presidents discussed to strengthen our membership: provide motivations to attend meetings; provide opportunities to go beyond the chapter level; strengthen work within the committees; offer chapter competitions or

challenges; recognize chapter accomplishments statewide; find strong local projects that will attract members and especially younger members; increase diversity in chapters; encourage carpooling for Fall meeting or State Convention; provide projects that every member can do; write notes to early educators or invite them to a special session during which pride in the big picture is shown; or invite your dropped members and encourage their reinstatement..

In addition to leadership training, I have attended the final finance committee meeting and audit for the 2011-2013 Committee in Albuquerque in July. I also attended a planning session for the fall meeting to be held at The Courtyard by Marriott. The contract for fall meeting was finalized and signed. I look forward to traveling around the state and visiting each of you in your chapters. Please work with me as we strive as a state to know our Theta State Sisters better. Sometime it can be as simple as an email, text, phone call or card that just says you care! Our society will directly benefit from an open communication that enables each member to articulate their feelings, express their plans, share their ideas, and understand each other's viewpoints.

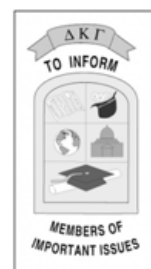

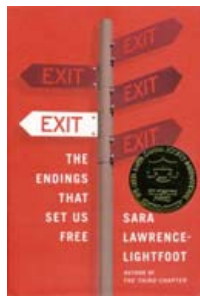

Need A Good Read?

Dr. Sara Lawrence-Lightfoot, author, explores ways people leave one thing and move on to the next; how humans anticipate, define, and reflect on departures. As educators, DKG members are involved in the exits of students and colleagues.

EXIT finds wisdom and perspective in the possibility of moving on and marks the start of a new conversation. A committee member commented, "This is a book I

could read countless times. I had difficulty putting it down." All people must maneuver personal exits during lifetimes, and in varied roles. We must also support students, children, friends, relatives, colleagues, neighbors, and even strangers through their own exits as they sashay or stumble toward new beginnings. A MacArthur (genius award) sociologist, **Lawrence-Lightfoot** is an endowed professor at Harvard Uni-

versity. A passion for education runs deep in her family history. In 1993, she was awarded the George Ledlie prize for research for literary merit and humanitarian achievement; for research that makes the most valuable contribution to science and to the benefit of mankind.

What's Your Brand?

What do people think of when you tell them you are a member of Delta Kappa Gamma? **John Parke** is working with DKG at the International level to address our Society's brand. In his presentation at the SW Regional Conference, he focused on global trends that impact DKG and 10 things we can do to benefit from

these changes. He presented a workshop on personal branding for personal and professional success.

According to **Parke**, in order to determine "your brand," seven Strategic Plan Components must be addressed: Values, Vision, Mission, Pillars, Tactics, Measurement, Roles & Responsibilities of members. In using

a business model, DKG must first focus on:

- 1) Getting dropped members back (values);
- 2) Identify why members are lost;
- 3) Investigate why members are turned down;
- 4) Initiate new members.

Need New Leadership Tools?

It is tough being a woman in a man's world. **Katie Snapp** reminded us that, "We don't get what we want; we get what we plan for." At the All States' Breakfast, **Snapp** discussed why women are not advancing as rapidly as some think. For example, in Non-profits, 50

percent of the workers are women, but only 1/5 of the leadership are women. She asked, "Why?" The answer came. "Our role models are often men." **Snapp** said, "A lack of confidence equals a lack of leadership." Essentially, women often lack confidence that would lead to

leadership roles. **Snapp** encourages every woman to read *17 Women Who Shook the World*, by **Preethi Burkholder**, and *The Teachers' Lounge (Uncensored)*, by **Kelly Flynn**, as well as her own book, *Skirt Strategies: 249 Success Tips for Women in Leadership*.

This will be a hands-on workshop. Individuals should bring one current copy of their chapter rules, the In-

ternational Go-To Guide for Chapter members, a copy of the International Constitution and Standing Rules (on www.dlkg.net website), a copy of the Theta State Bylaws and Standing Rules (on www.thetastate.weebly.com), and a copy of working materials sent to chapter presidents from the Bylaws Committee via Dianna Valdez .

Dr. Paula A Dent was awarded the International Achievement Award in 1999. She was described as "an innovator, a facilitator and a mentor—one who exemplifies the highest qualities of Society leadership."
