MEMBERSHIP THOUGHTS: Is 300 Members Possible?

Thoughts from Pat Graff, NBCT, TS First Vice-President and former Membership Chair:

Treasurer Yvette Moore announced at the state's 2019 Fall Meeting in Albuquerque that we currently have 266 members in New Mexico DKG. Since it is still early in the DKG calendar year, consider this: What if each chapter made a little extra effort and as a state we hit 300 members total?!

For the past two years, state membership has been at 295 or 297. This includes honorary and reserve members. If each chapter managed to induct or reinstate 3 new members, we would surpass 300 members for the first time in several years!

Even during the meeting as reports were given, chapter leaders were talking about new members they were recruiting and possible reinstatements. One chapter announced it will be inducting four new members this fall, and another chapter has at least five potential members in the pipeline. Perhaps the goal of 300 members IS possible!

New Mexico DKG (Theta State) has lost more than a quarter of its members in the last decade, and to increase our membership would be a significant step forward for our folks. Our issues, our service projects, our leadership, our voices MATTER! And the more members we bring to the table, with their enthusiasm and energy, the more effective we ALL are!

Let's see what we can do in the next few months.

Parliamentary Questions

At our Theta State Fall Executive Board meeting, several questions were raised that require our attention. The following three queries were asked of our international parliamentarian. Her replies are as recorded below:

- **Q.** May collegiate members vote in all circumstances?
- A. YES. Collegiate members have all of the privileges of membership, except that they cannot hold elected office. They can make motions, debate, and vote, just as any active member can.
- **Q**. Given the fact that our International Constitution mandates that all states be known by their geographical name, does this apply to chapters as well?
- **A.** NO. The Constitution, Article I, Name, Section B. line 10, reads, "Each chapter shall be named by the state organization." Later, your state Bylaws indicate that the Executive Board will do the naming of chapters. In response to the further query about the validity of a chapter's renaming itself, the answer is: "That chapter is not in compliance with the DKG Constitution or the New Mexico State Organization bylaws; therefore, that chapter's action is null and void."



- **Q**. Should our Bylaws Committee proceed in changing all references to Theta State in our Bylaws and Standing Rules, if there is a possibility that changes are going to be made at the 2020 Convention in Philadelphia regarding names?
- **A.** You should change all references to Theta State in order to bring your governing documents into compliance with the current version of the Constitution.


